The Operator, Go Ahead Ireland, (“GAI”, “we”, “us”) will collect and use certain personal data relating to you in connection with this Notice. The main purposes for which we use your personal data are to issue you with this Notice, to process any payment you make in respect of the alleged offence and where necessary, to institute proceedings against you in respect of the alleged offence. The main legal bases on which we process your personal data are that this is necessary for the performance of tasks carried out in the public interest or to comply with our legal obligations.

You have certain rights under data protection law, subject to certain exemptions, including the right to: (i) request a copy of your personal data; (ii) request that any inaccurate data that is held about you is corrected or updated; (iii) request us to delete personal data that we hold about you; and (iv) request that we no longer process your personal data for particular purposes, or to object to our processing of your personal data for particular purposes.
